Article I. - PARTICIPATION AT THE FAIRS AND ASSIGNMENT OF AREAS

The basic precondition for the participation at the Fair is the delivery of the properly completed Binding Application to ABF, a.s. (hereinafter referred to as ABF only) by the closing date and the payment of the advancement for the required area within the due term stated in the invoice. After the receiving of the Binding Application, ABF will send to the Exhibitor a confirmation of its receipt (this event will establish a contractual relationship between ABF and the Exhibitor), and an advance invoice for the exhibiting firm and for the amount as follows:

- a/ - in the case of Applications evidently delivered to ABF by mail or in person by March 31, 2005 inclusive - 60 % of the price of lease for the ordered area and Exhibitor's Registration Fee in full amount. The remaining part of the area lease amounting to 40% of the total price is due for payment in May 2005 on the basis of an invoice issued.
- b/ - in the case of Applications evidently delivered to ABF after April 1, 2005 inclusive - 100 % of the price of lease for the ordered area.

After the payment of the invoices and final processing of applications, the Exhibitors will receive a raster of exhibition areas with the marking of their allocated places. **ABF reserves the right to reduce the ordered area, to change its shape and location - the order of the participation is binding for the Exhibitor also in this case.**

The advance invoice for the ordered services will be sent before the beginning of the Fairs and its full payment will be a precondition for the beginning of the assembly of the exposition. The final invoice including VAT and deduction of advances will be sent after the finishing of the Fairs.

If the Exhibitor fails to settle the charges for the area lease and/or the Exhibitor's Registration Fee in full amount and due term, ABF will confirm the allocation of the area lease to another applicant without the original Applicant being allowed to claim from ABF for possible expenditures incurred.

If the confirmed area is not available to the Exhibitor for reasons caused by the Organiser of the Fair, the Exhibitor is entitled to the reimbursement of the lease charge paid. The Organiser will not accept and will not indemnify any claims for damages which the Exhibitor could have incurred for this reason.

Article II. - TERMS OF PAYMENT

All prices are stated without VAT.

Basic price of the lease and Registration Fee include:

- Lease for the area during the assembly, Fairs and dismantling
- Insertion into the Fair Catalogue to the extent of data stated in the Order of Registration into the Catalogue
- Insertion into the orientation system of the Fairs
- Five Exhibitor's Cards for the firms with an ordered area up to 30 m²
 - One Exhibitor's Card for every 10 m² (including a part of this area) exceeding the area of 30 m²
- Assembly/Dismantling Cards for the Working Teams
- Cards for free entries into the area during the assembly and dismantling works (during the assembly and disassembly the parking time in the area is limited - the vehicle entry is allowed against depositing a security)
- Fair Catalogue
- Free registration in the Building Information System
- Invitation to the common party

Basic price of the lease and Registration Fee do not include:

- External walls of the stand, nor any other equipment of the stand, nor the walls of the neighbouring stands.
- Other records about the firm - i.e. branch offices, divisions, business representations, etc.

For each of the other firms which the Exhibitors will present in their expositions (by the presentation of exhibits, with an advertisement panel, company logo, commercial name, folders, video programmes, etc.) the Exhibitor is obliged to pay the Co-exhibitor's Registration Fee. The firm properly registered in this way will be presented in the Fair Catalogue to the full extent as the Exhibitor. **In the case of any breach of this principle the Exhibitor will be obliged to pay the Co-exhibitor's registration Fee in a double amount during the Fairs.**

Cancellation Conditions

ABF will retain the below stated percentages of the price of fulfilment, depending on the term of possible cancellation of the Binding Application:

- 20 % on the cancellation of the Binding Application in the term from April 8 to April 30, 2005 inclusive
- 40 % on the cancellation of the Binding Application in the term from May 2 to June 30, 2005 inclusive
- 80 % on the cancellation of the Binding Application in the term from July 1 to August 9, 2005 inclusive
- 100 % on the cancellation of the Binding Application in the term from August 10, 2005 to the beginning of the Fairs

The Cancellation Conditions shall apply to the cancelled areas as well.

The firm, whose Binding Application for Participation has been delivered to ABF, will be obliged - in the case of cancellation of its participation or non-participation at the Fair without any official cancellation (100%) - to settle the cancellation fees even in the case that it has not settled the advance invoice or any other invoice.

Any cancellation of its participation must always be made in writing. Registration Fees shall be forfeited in full amount, regardless to the term of the cancellation of the Binding Application or in the case of non-participation without cancellation.

Article III. - EXHIBITION AREA

ABF leases:

- indoor exhibition area without any equipment, with possible power supply, water pipeline, sewerage, telephone and cleaning facilities on the basis of the Application. **The minimum depth of the expositions is 3 m.** Minimum sizes of the exhibition areas are stated in the Binding Application for the Participation of the firm. **The expositions whose depth does not exceed 4 metres cannot be higher than 250 cm.**
 - outdoor exhibition area on the dedicated free areas of the Exhibition Centre. Minimum areas, of the expositions situated on the outdoor area are 4 x 3 m, i.e. 12 m² or 20 m² (roof over the stand), respectively.
- If the exhibiting firm itself does not provide for the stand or if it does not order its erection by ABF, it will have only the ordered exhibition area without borders at its disposal. The architectural concept in the exhibition halls counts on the implementation of the classical rectangular exhibition raster, within which the following exhibition areas will be available:
- row areas with free front side
 - corner areas with two open sides - along which the visitors walk
 - U-shape areas (front) with three open sides - along which the visitors walk
 - island areas where all of the four sides are free.

Article IV. - SAFETY AND INSURANCE

The Exhibitors are not allowed to store or use in their expositions or in the territory of the Exhibition Centre any combustible and radioactive substances, exploding materials, acids, poisons and other health harming substances. The Exhibitors are obliged to observe the technical, fire and safety regulations which are in force.

At the Exhibition Centre, ABF is not responsible towards the Exhibitors and their Co-exhibitors, or their assembly firms, for any losses, destruction or any damage concerning the exhibits, equipment and outfit of the stands, goods, packages, packing materials whatsoever, whether the loss, destruction or other damage occurred during the assembly, transportation or during the Fairs. Therefore the Exhibitors as well as the assembly firms are obliged to have all the exhibitions and above mentioned materials insured, it applies to the Exhibitors' own materials as well as to those belonging to their Co-exhibitors and for the entire period of their presence at the Exhibition Centre, such an insurance being made against any danger that can be considered in the connection with the Exhibitors' property.

Article V. - TECHNICAL AND FIRE REGULATIONS, ENERGY USAGE REGULATIONS AND DIRECTIVE FOR THE USE OF TEMPORARY ELECTRICAL INSTALLATIONS

During the time of the Fairs as well as during the assembly and dismantling works **smoking and naked flame handling is prohibited** in all of the indoor areas.

The Exhibitors are obliged to observe, during the assembly, in the course of the Fairs and during the dismantling, generally binding law regulations of the Czech Republic and the EU, as well as technical standards for the above mentioned areas including work safety regulations and handling all technical equipment. Furthermore, the Exhibitors are obliged to observe appropriate fire regulations valid for individual exhibition areas and the instructions of the authorised members of the fire assistant service and of the ABF staff. Temporary electrical devices must be in accordance with the ČSN 341090 standard and must comply with all other electro-technical regulations in force. The electrical installation works can only be carried out by a firm duly authorised to do so, i.e. possessing the "Certificate of Competence according to the Law No. 174/1968 Coll., Art. 4(f) and Art 3(2) of the ČUBP and ČBÚ Regulation No. 20/1979 Coll."

Article VI. - BASIC PRECONDITIONS FOR THE ERECTION OF THE STAND

The erection of the Stand is offered and carried out by ABF. The Exhibitors who will not make any use of this offer and who prefer to ensure the erections of their stands by themselves or through their agencies **are obliged to submit the ground plan and front view of the stand with the marking of dominant heights, as well as with the marking of power, water and sewerage system lines, for approval to ABF, not later than July 30, 2005** and to announce the name of the implementation firm. **The Exhibitors are obliged to maintain the raster of the exhibition area, i.e. they may not exceed the designated area with anything from the ground plan point of view and the same applies to the dominant heights which are shifted out (Important! - the roofs of outdoor stands generally exceed their ground plan).**

The Exhibitors are obliged to leave the exhibition area after the dismantling in the same conditions in which it was before the beginning of the assembly. Any destruction, exceeding pollution etc., will have to be paid for by the Exhibitor according to the real cost of the removal of damage (pollution).

Article VII. - FINAL PROVISION

All complaints on the part of Exhibitors towards ABF during the assembly and in the course of the Fairs shall be produced in writing to the Managing Director of the Trade Fair Administration (ABF) or to an authorised representative before the end of the Fairs, or during the dismantling works until they are completed.

Any other claims on the part of Exhibitors towards ABF can be applied for within 2 weeks after the end of the Fairs. Any possible claims of the Exhibitors will cease to exist upon the expiration of 6 months after the end of the Fairs.

Article VIII. - CLOSING DATE FOR APPLICATIONS AND ORDERS

The Fairs will be open for the public: Tuesday – Friday from 10 a.m. to 6 p.m. and on Saturday from 10 a.m. to 4 p.m.

Article II. - EXHIBITION AREA

ABF leases:
indoor exhibition area without equipment with the options of the inlet of power supply, water and sewerage lines, telephone, connection to the Internet and cleaning services on the basis of orders. **The minimum depth of the expositions is 3 m.**
The minimum sizes of the exhibition areas are provided for in the Binding Application for the Participation of the Firm.
outdoor exhibition area in the designated free areas of the Exhibition Centre. The minimum sizes of the exposition in the outdoor area are 4 x 3 m, i.e. 12 m² or 20 m² (roof over the stand), respectively.

Height of halls, load of floors
It makes it possible for a limited number of expositions to erect double-floor stands as well as dominant heights. The effective height varies from 3.0 to 8.0 m. Maximum height of an exhibit for transportation to the halls is 3 m. Basic load capacity of floors is 250 kg/m².

On an extra order in the Binding Application it is possible to ensure individually the reinforcement of the floor up to a load capacity of 750 kg/m². Maximum weight of an exhibit is 2.5 t.

Article III. - TECHNICAL SERVICES

On the Exhibitor's order it is possible to provide the inlet of power supply, water and sewerage, telephone and cleaning services (once a day vacuum-cleaning and emptying of the waste basket) to all expositions in both indoor and outdoor areas.

The advance invoice for the ordered services will be sent before the beginning of the Fair and its settlement will be a necessary condition for the beginning of the assembly of the exposition. The final invoice, together with VAT and invoice deduction will only be sent after the finishing of the Fair.

Order of power supply
For the stands which are not ordered with ABF your own switchboard is presupposed - it should be adapted to the 5-wire distribution system, or the voltage system TNS 3L + N + PE, 50 Hz, respectively. Single-phase connection of the exposition is carried out through a usual plug of 230V/16A - L + N + PE, three-phase consumers must be fitted with a recommended ball plug of 400V/32 A - 3L + N + PE. The connection of larger power inputs will be carried out upon an agreement with ABF. Electrical equipment of Exhibitors which is not fitted with separate operation N and protecting PE (zero) wires, or which is not fitted with a protecting wire, without its featuring double insulation, or the wires of which do not have appropriate section, will not be allowed for the reason of the protection of visitors from electric accidents and for fire reasons. In the case of necessity it is possible to use the work of an electrician at a price of CZK 360.- per hour (each hour started is taken into account), which is to be paid immediately at the cash desk of the Trade Fair Administration.

The firm implementing the stand shall be liable for the inspection of electrical installations.

We ask the Exhibitors to consider their real demands for the power supply input. For the purpose of a more exact order we provide the following examples:
Illumination of a 9 m² stand about 0.5 kW, refrigerator 0.4 kW, kitchen complete set about 3.5 kW, coffee machine about 0.8 - 1.2 kW, fast water heating unit about 2 kW, two hot-plate cooker about 2 kW. These power inputs are only for your orientation - it always depends on the particular electrical appliance which is connected.

CAUTION! In the case you intend to use a refrigerator in your stand, we recommend to order the refrigerator circuit separately, as it will not be turned off overnight. The price does not include the power input of electrical energy. This power input must be included in the electrical power input order.

Order of water and sewerage
The connection of the sink, i.e. of an ordinary battery to the shut-off valve and of an ordinary siphon outlet with a 5/4" hose is included in the price of the "water inlet and sewerage". **The lease of the sink is not included in the price of water inlet and sewerage.** If you want to make a wider use of the plumber's service, you will be charged CZK 360 per hour (each hour started is taken into consideration) and you will pay this service at the cash desk of the Trade Fair Administration. Additional costs arising on the basis of installation of a connection point at a distance exceeding 10 m from the technical channel will be charged on an individual basis.

Connection to the INTERNET network
Connection to the INTERNET is implemented through a connection line to the local network "ETHERNET 10/100MB". The Exhibitor's PC must be equipped with the ETHERNET 10/100MB network card with a possibility of the RJ-45 connector connection. For the connection into the network it is necessary to set the acquisition of an IP address from the DHCP server. The allocation of fixed addresses is possible in exceptional cases for an additional fee and subject to a previous inspection by a technician of ABF. The Exhibitor will not pay any other telecommunication fees.

The Exhibitor is responsible for protection of the connected equipment from viruses, spyware, adware and other harmful programs. In the case of infection of the Exhibitor's equipment connected, the organiser is authorised to disconnect the connection line without any compensation until the harmful programmes are removed.

Technologies of carpet adhesives in halls no. 1, 2 and 7
For the laying of carpets into expositions in halls no. 1, 2 and 7 it is necessary to adhere to the following procedure :

First glue a masking – paper tape onto the concrete floor, and then an arbitrary two-side carpet tape. It is possible to buy the masking tape directly in the Exhibition Centre. The Exhibitor is obliged to hand over the exhibition area by the closing deadline of the dismantling work as absolutely empty and clean – in the condition in which it has been taken over. In the case of damage and contamination of the exhibition area, the Exhibitor is obliged to settle the damage incurred in full amount.

Other services
ABF will provide for working illumination, fire service, ordinary cleaning of the communication corridors, the establishment of dispatching and customs services, health service, insurance service, telephone and fax centre for the Exhibitors, press centre service, business centre, the Fair Protocol and catering facilities.

Article IV. - ERECTION OF STAND

On the basis of a separate order distributed by ABF together with the Binding Application, ABF will ensure the erection of a stand – exposition in both indoor and outdoor areas.

Article V. - TECHNICAL AND OPERATING PRECONDITIONS

The architectural realisation and the operation of the exposition must not disturb or limit other expositions.

The firms neighbouring with the rear or side walls whose height exceeds the height of the neighbouring stand are obliged to treat this wall in a neutral manner from the constructional and graphic points of view. The use of these raised walls for their own advertising purposes is unacceptable and if they do so, the firms will be forced to remove the advertisements of this type and to treat these areas in a neutral manner at their own expenses.

The outline of the exhibition stands must not exceed the outline of the leased exhibition area, which applies to the space above the ceiling structure of the stand as well.

Possible overhang of the collar or eye-catcher of the stand to the path is allowed on the basis of a preliminary approval given by ABF, if the minimum height of the bottom edge is 3 m, and it will be subject to the payment of CZK 1450.

Except for handling trucks, entry into the exhibition areas is prohibited for any means of transport and cars.

If the floor of the hall is damaged, the Exhibitor will be obliged to reimburse the damages to the full amount.

Smoking and naked flame handling is strictly prohibited in all of the indoor exhibition areas, any breach of this ban will result in a fine paid on site.

No electrical appliances may be left in operation without any control and unattended. When you are leaving the place, the appliances must be disconnected from the mains.

It is not allowed to hang any eye-catchers, flags, etc. on the structure of the halls with the exception of the cases pre-discussed with ABF and subject to a payment.

During the assembly it is forbidden in the indoor premises to cut and grind any building elements, which causes excessive pollution and dust (plasterboard, tile materials, fibreboard and other similar materials).

The stand must not touch the structure, walls and roof of the exhibition halls with any of its parts. The distance between the highest point of the stand and the hall roof must be at least 70 cm.

It is forbidden to discharge the remains of paints and other toxic substances which could pollute or otherwise endanger the environment into the sewerage, sinks and basins. The Exhibitors or the firms authorised by the Exhibitors are obliged to take these substances away and ensure their disposal on their own expenses.

Storage of any materials in technical corridors (in particular behind the rear wall of the stand) is unacceptable for fire, safety and operational reasons. The storage of the packages, including their removal and return delivery to the stand can be ordered from the contractual forwarding service of ABF.

During the Fairs it is permitted to perform audio-visual, acoustic, musical, dancing and other productions for the time not exceeding 8 minutes once an hour, and only provided that the other Exhibitors will not be disturbed by the operation of these facilities. If this condition is breached, the Exhibitor will have to pay a fine amounting to CZK 5,000.- and in the case of repeated breach it will be forbidden for the breaching Exhibitor to operate all such productions.

The exhibits which will be presented in the operation can only be serviced by the persons authorised thereto. The exhibits to be presented must be secured by the Exhibitor in such a way that no third party could handle them wilfully.

Except for the prescribed working business hours of the Fairs and permitted time interval for the supplying of the stands it is forbidden to stay in the exhibition areas. Please, respect for this reason the instructions of the Security Service and of the ABF staff.

By the deadline of disassembly works the Exhibitor (or the assembly firm of the Exhibitor) is obliged to hand over the leased exhibition area empty and in the conditions in which it was taken over, i.e. also the floor covering (carpets, PVC) must be removed as well as the sticking carpet tapes, such a removal being carried out at the expenses of the Exhibitors. Should the exhibition area be damaged (by boring, cutting, breaking, excessive polluting, etc.), the Exhibitor will be obliged to reimburse the damages in full.

If the deadline for the clearing of the exhibition area fails to be observed, a penalty amounting to CZK 5000 per m² of the non-cleared area will be charged. In the necessary case the exposition will be cleared by ABF at the expense of the Exhibitor. The risks associated with the clearing shall be borne by the Exhibitor.

The placement of billboards, eye-catchers, banners as well as the distribution of printed and other materials out of the stand area is permitted only for consideration after prior negotiations with the ABF Trade Fair Administration in writing.

Article VI. - HANDING OVER OF THE BACKGROUNDS FOR THE REALISATION OF TECHNICAL CONNECTIONS AND STANDS

The Exhibitors who order the erection of the stand from ABF will send their orders within the term provided for in the Stand Order. Any changes relating to the Order of Technical Services, construction and equipment of stands required by the Exhibitor additionally after the term of commencement of the assembly will only be managed after the fulfilment of the properly ordered work and services towards the other Exhibitors. These additional orders of work and services can be charged by ABF with a surcharge amounting to as much as 100% of the price calculated. The payment shall be made by the Exhibitor in cash on site.

The Exhibitors who ensure the erection of the stand on their own or through an advertising or realisation agency will send to ABF and within the term provided for in the Order Catalogue of Services **the design of the stand for approval** (in the front view and ground plan) where all possible dominant heights and eye-catchers, including the stand orientation within the framework of the ordered area will be drawn by means of **the location dimensioning of the inlets of power supply, water and sewerage including the name of the implementation firm. For double-floor expositions, a structural report is required!**

In the case that the Exhibitors fail to send appropriate backgrounds within the requested terms, they will expose themselves to the danger of possible difficulties during the realisation of the stands and possibly to additional costs connected with the displacement of the inlets of power supply, water and sewerage.
